Town Center Core Project Reaches Major Milestone

Town Council selects preferred vendor for negotiation of a Memorandum of Understanding (MOU) and Development Agreement

The Morrisville Town Council selected Armada Hoffler Properties, Inc. and authorized town staff to begin negotiations for a Memorandum of Understanding (MOU) and a Development Agreement for the Town Center Core Demonstration Project at its January 23 Town Council meeting. Armada Hoffler Properties was one of three qualified responses received for a Request For Proposal (RFP) that was issued this past fall. This decision is pivotal to the progress of the development of a Town Center in Morrisville.

The Demonstration Project is a piece of the overall Town Center Core Vision, and is a 4-story mixed-use project composed of commercial, residential, and structured parking on the block between Jeremiah Street and Carolina Street on Town Hall Drive. The first phase is proposed to consist of 172 residential units, 20,250 square feet of commercial space, and a 350-space parking structure. A public library and surface parking will be constructed by Wake County separately and concurrently. The Demonstration Project will be the cornerstone of future development phases, which includes residential, commercial, public facilities, open space and parking in a vibrant, walkable environment.

The Town has worked with Development Finance Initiative (DFI) with the UNC School of Government to develop the vision for the Town Center Core as well as perform the necessary work to structure a potential public private partnership between the Town and a selected developer for the Demonstration Project. The next step is to develop an MOU and eventually a Development Agreement. The MOU is expected to be executed in the spring of 2018 and the Development Agreement is expected to be executed in the summer of 2018. Demonstration Project construction is anticipated to begin in the summer of 2019 and be completed in the spring of 2021.

"The Town Center Core Project will establish a much-needed downtown area and will give our residents a gathering place to enhance our connectivity with the community," said Mayor TJ Cawley.

Road work related to the Town Center Core Project is scheduled to begin in June. The Carolina Street extension project will connect the existing Carolina Street to Town Hall Drive through a roundabout. It will also connect Foxglove Drive from Carolina Street to Jeremiah Street. Sidewalk and lane closures will be required on Town Hall Drive. Also, the work will require one weekend closure of Town Hall Drive from Jeremiah Street to the Chamber of Commerce building (260 Town Hall Drive). The detour route during that closure will be McCrimmon Parkway to Church Street to Morrisville Carpenter Road.

The Town originally approved a Town Center plan in 2007 that envisioned a lower density, historic crossroads concept. A number of implementation goals of that plan have been completed. The vision for the Town Center has since changed, reflecting market demand for a different mix of uses and amenities and in the winter of 2016, Town Council endorsed a revised Town Center Core concept.

"While the concept has changed, the vision for a downtown in Morrisville has been supported by Town Councils for many years," said Council Member Liz Johnson. "I am looking forward to this vision we've worked so hard to develop come to fruition."

- 12. Historic Walking Loop Trail is under construction, anticipated opening Spring 2018

Police Department to Hold Neighborhood Watch Information Meeting

The Morrisville Police Department will hold an information meeting for the public to provide guidance and answer questions on how to create and implement a Neighborhood Watch program. The next session is scheduled for Saturday, April 28 at 2 p.m. and will be held at Cedar Fork Community Center (1050 B Town Hall Drive). Visit www.townofmorrisville.org/NHW to register to attend.

A Neighborhood Watch program is not designed to substitute for police protection. Rather it is an extension or supplement in assisting the police in making neighborhoods safer for all residents. Neighborhood Watch operates under two principles. First, when neighbors get to know and watch out for each other, they watch out for each other's property as though it was their own. Second, Neighborhood Watch helps to create an identity within the neighborhood, which in turn fosters sense of pride, and belonging for the participants. While a Neighborhood Watch program can be a useful tool in keeping a neighborhood safe by engaging the residents that live there, it's important to understand what it takes to create and implement a successful Neighborhood Watch program.

Public Works Department Earns Accreditation

The Public Works Department has been awarded the American Public Works Association (APWA) Accreditation designation. The APWA Accreditation program recognizes public works agencies that go beyond the requirements of the management practices established nationally in the public works industry, as contained in the APWA Public Works Management Practices Manual. The Town of Morrisville Public Works Department received the Accreditation award from APWA Region III Director Keith Pugh at a presentation ceremony during the February 27 Town Council Meeting (pictured below right with Council and staff).

The Accreditation of Morrisville's Public Works Department indicates the department met all applicable Accreditation documentation and practices over time. "The awarding of the APWA Accreditation shows we have dedicated ourselves to concepts of improvement and in-depth self-assessment of department policies, procedures and practices. The heroes of this prestigious APWA award are the public works staff, whose

mission is to provide public works services and programs that contribute to making the Town of Morrisville a great community," said Blake Mills, Director of Public Works.

The Town of Morrisville becomes the 136th agency in North America to be awarded Accreditation and the second agency in North Carolina. In addition to Morrisville, Garner, N.C., is also accredited. The Public Works Department is Morrisville's 4th department to receive accreditation designation. The Police Department was accredited by the Commission on Accreditation for Law Enforcement Agencies (CALEA) in 2009, the Fire/ Rescue Department was accredited by the Commission on Fire Accreditation International (CFAI) in 2011, and the Parks, Recreation and Cultural Resources Department was accredited by the Commission for Accreditation of Park and Recreation Agencies (CAPRA) in 2014.

Experience has shown that basic training in disaster survival and rescue skills improves the ability of citizens to survive until responders or other assistance arrives.

The Fire/Rescue Department offers Community Emergency Response Team (CERT) training, free of charge! This program educates people about disaster preparedness for hazards that may impact their area and trains them in basic disaster response skills. Using the training learned, CERT members can assist others in their neighborhood or workplace following an event when professional responders are not immediately available to help. Police Department Launches Community Crime Map



The Morrisville Police Department and LexisNexis Risk Solutions recently partnered to provide a new way for the public to stay informed about crime in Morrisville. The Police Department now has an online crime map called Community Crime Map at www.townofmorrisville.org/communitycrimemap that maps and analyzes crime data and alerts residents about crimes in their area.

Morrisville Residents can view a map and grid with all of the crimes in their area, sign up for neighborhood watch reports that automatically email a breakdown of recent crime activity, and submit an anonymous tip about a crime directly to their law enforcement agency. Community Crime Map gets data from the Police Department's records system to keep crime information updated online and in a mobile app. The Community Crime Map cleans and geocodes the crime data, then displays all of the incidents on a map, grid and analytics dashboard along with some basic information about the incidents, including the type of crime, location type, block-level address, date and time.

Residents can view the map online and sign up for alerts at www.townofmorrisville. org/communitycrimemap. The app is available to iOS users by searching "Lexis Nexis Crime Map". A video tutorial on how to use the tool was prepared by Morrisville Police Chief Patrice Andrews, and is on the website.

2017 Citizen Survey Results Available

Morrisville conducted its most recent Citizen Survey in the fall of 2017. The National Citizen Survey (NCS) report is about the "livability" of Morrisville. The phrase "livable community" is used here to evoke a place that is not simply habitable, but that is desirable. It is not only where people do live, but where they want to live. Great communities are partnerships of the government, private sector, community-based organizations and residents, all geographically connected. The NCS captures residents' opinions within the three pillars of a community (Community Characteristics, Governance and Participation) across eight central facets of community (Safety, Mobility, Natural Environment, Built Environment, Economy, Recreation and Wellness, Education and Enrichment and Community Engagement).
